Adoption of the Minutes of January 10, 2013 Moved as corrected; Jeff Bass, Second Charles Comer New Business:

Welcome, introductions:

Review and update bylaws, mission statement: JWP and Joel Ziev have reviewed and made recommendations for discussion of the 2000 bylaws and mission statement. Corrections and additions were made. JWP will email corrected version to be adopted at next meeting.

2013: Committee actions: What do we want to do in 2013? Ideas in discussion:Storm drain markers again, Construction of signs, Bilge socks, Education with Leeds Pond Science Museum, Redevelop notice system for sewage spills and issues. Organize an alert system - Raise with WAC again. Need to develop relationships with sewage districts. JWP will review LISS Futures Fund, closing in April, to see if there is an educational grant we can undertake.

Power Points Presentations: JWP has developed several power point presentations; History of Manhasset Bay, Flora and Fauna of Manhasset Bay, and Boater Pollution Prevention. Gardening with natives plants for wildlife is in the works. JWP is available to give presentation to civic organizations, libraries, school groups etc.

Long Island Sound Study Meeting: A large part of the meeting focused on Sandy aftermath response with reports on shoreline damage from American Littoral Society, the Federal coordinated response from a member of the EPS field team, and funding access for storm related damage. The 20 year revision of the CCMP (Comprehensive Conservation & Management Plan) is moving forward and expected to be on schedule. This will be more general document than the 1994 CCMP without specific actions, more of a framework. The LISS Citizens Summit 2013 is scheduled for Friday April 26 Iona College, New Rochelle 10am and will also focus on Sandy Response.

Joint Committee Meeting: Scheduled for Tuesday, May 14, 7pm at the Bryant Library, Roslyn. Our speaker will be Dr. Gobel of Stony Brook.

DEC NOI seminar: Good news is that the DEC has created Excel based worksheets for figuring the design manual components for an NOI that are interactive and have formulas imbedded. The not so good news is that you will have to hire an engineering firm to review the NOI before it goes to the state, so if you have not already, that should be built into permit fees.
